RULES FOR PARENTS & STUDENTS

Fees: Students are required to play their fees in cash or bank draft only before 10th of the months failing which a penalty of rs. 20/- per day shall be levied. If the student fails to remit the fee with fine by 15th of a month, he shall not be permitted to sit in the classroom and his continuous absence for more than six days will make him liable to loose his registration and will have to seek re-registration with payment of prescribed fees. Registration, admission fees and monthly fees already paid by the student shall stand forfeited on his discontinuing the course at any stage. Under no circumstance fees once paid shall be refunded.

Discipline: Observance of discipline is must for every student admitted to the college. Student must abide by all the rules and regulations of the college written or unwritten and thereby create an atmosphere conductive to learning and establishment of healthy traditions.
